The duration of a student's eligibility to receive a Federal Pell Grant is the equivalent of 6 years of funding. The maximum amount of Pell Grant funding a student can receive each year is equal to 100%. The 6-year equivalent is 600%. Once you have received the Federal Pell Grant for 600%, you will no longer be eligible for the Federal Pell Grant for future semesters.
